

# SEEDED ACREAGE REPORT

**The Seeded Acre Report must be completed signed and returned to us by June 30th.**

**Please note that we will accept any list or spreadsheet detailing your acres and legal land locations, however you must fully complete the top portion of the provided seeded acreage report and sign it.**

This form is to report how many acres you were able to seed this year to ensure your farm is properly insured. If you were able to seed more or less than the estimated acres you provided on your application, this may change your premium amount as it is on a per acre basis. You will receive written notification of any adjustments to your policy and premium.

- 1** The name you assign to your field
- 6** Acres that could not be worked or seeded due to being too wet
- 2** Legal land description for each parcel of land
- 7** Acres not in a condition or intended to be seeded. Including summer fallow, sloughs, etc.
- 3** Enter the **specific** commodity seeded to the field ('Red Spring Wheat' instead of 'Wheat')
- 8** Sum of your Seeded Acres and Too Wet to Seed acres (Box A + Box B) = Box D
- 4** Specify Y or N if irrigated
- 9** If you no longer own or operate a legal land description provided, please draw a line through the entire row
- 5** Acres seeded to the crop on the legal land
